

# **EOC Meeting Survey Results**






8 votes for level 3 satisfaction7 votes for level 4 satisfaction8 votes for level 5 satisfaction




## Do you feel that the meeting materials were at the right level of detail?










#### Comments:

It is difficult to have dialouge on teleconferences


Not to use too much buzz words; subjects have large spectrums, difficult to address them in time limited and number of subjects

"Time frame of the meeting: some details should be left to us to read. At the beginning the meetings were scheduled for 1.5 hr - it was extended to 2 hrs and still I had to leave the meeting because I had another meeting scheduled."

"We came up with the one hour teleconference meetings as a means of increasing efficiency between quarterly in person meetings. We recently increased the time from 1 hour to 90 minutes, but still were not able to complete it within the allocated time. I believe we have further opportunities to be more succinct in the reporting."

"Detailed overview of industry updates where there are no issues to discuss seem to be over the top sometimes. When document materials have been circulated in advance and there are no issues to discuss, a brief summary should suffice. If participants raise a question or issue, then additional background or more details could be brought up."

"The meetings spur good dialogue and engagement, the pre read package is always very long, is there an opportunity for it to be distributed in an interactive pdf, its difficult to flip between the content and agenda, for those of us who are trying to be 100% digital."

"I believe that the teleconference-only meetings should be focused on significant or time-sensitive items only. It is not necessary to cover everything, every month"

"Would be helpful to continue to use Zoom so those on the phone can "see" where we are at as I find we jump back and forth a loth during these meetings. I also find that these meetings aren't always kept on track and that is why we struggle to get through the agenda items"
