### 2018 ACCOMPLISHMENTS SUMMARY

•Welcomed Manulife Financial and Canada Life Assurance as new CAFII Initiation Members.

•Made major contribution to industry advocacy efforts which persuaded Saskatchewan's Financial Consumer Affairs Authority (FCAA) to delay implementation of new The Insurance Act and related Regulations by one year to January 1, 2020 to allow time for many key components to be finalized.

•Persuaded Saskatchewan Ministry of Finance to remove 6% PST on creditor's group insurance products, a position not initially taken in its decision to reverse the August 2017 imposition of PST.

•Established strong, collegial relationship with the soonto-be-launched Financial Services Regulatory Authority of Ontario (FSRA)'s management team and Board of Directors. Resulted in an invitation to participate on FSRA's Industry Advisory Group (IAG) – Life and Health Insurance alongside CLHIA; and in securing Mark White, CEO of FSRA, as guest speaker at CAFII Reception event.

•Met with insurance regulators and policy-makers from the four Atlantic Canada provinces in their own offices, thereby strengthening CAFII's relationships with and gathering intelligence from Nova Scotia Superintendent of Insurance; Insurance Division of Financial and Consumer Services Commission of New Brunswick; Opportunities New Brunswick (government agency mandated to promote inbound business investment); Office of the Consumer Advocate for Insurance, New Brunswick; Prince Edward Island Superintendent of Insurance; and Newfoundland Deputy Superintendent of Insurance.



•Acting on Board's Strategic Plan-based commitment to evidence-based consumer and industry research, commissioned a major consumer study by Pollara Strategic Insights on experiences and satisfaction with travel medical insurance. Study results, which found high levels of satisfaction and high claims payout rates, were shared with regulators, media, and posted on the CAFII website.

### 2018 ACCOMPLISHMENTS SUMMARY

•Issued several CAFII research/news-based Media Releases. Resulted in 24 significant industry trade press stories published, including on News/Research section of website.

•Held a CAFII Board meeting in Montreal and, on the same day, an informal lunch and an Industry Issues Dialogue session with AMF staff executives. Afforded the opportunity to gain insights about the AMF's imminent Regulation Respecting Alternative Distribution Methods and its justunderway involvement in the IMF's 2018 Financial Sector Assessment Program return visit to insurance regulators in Canada.

•Finalized proposal and terms of reference, in co-operation with CLHIA and the Insurance Councils of Saskatchewan, for a "Restricted Insurance Agents Advisory Committee," to be launched in 2019.

•Organized a CAFII Special Purpose Board Meeting with FCAC Deputy Commissioner Brigitte Goulard.

•Strengthened CAFII's 2017-launched consumer-friendly website, with a new News/Research section; improved search engine optimization; new homepage "slider" to showcase videos; 16 new "vignettes" (short customer stories) about CAFII member products; and launch of our first website video.



•Secured invitation to participate as a key stakeholder in CCIR's condensed Annual Stakeholder Meetings. Subsequent feedback received from CCIR Policy Manager indicated that CCIR members appreciate that "CAFII is the best prepared of all the stakeholder groups."
